**AANBIEDING VAN SA BOERPERD SKOUE & STREEKKAMPIOENSKAPPE DEUR
INSTANSIES, KLUBS OF SKOUGENOOTSAPPE**

***PRESENTATION OF SA BOERPERD SHOWS & REGIONAL CHAMPIONSHIPS BY
INSTITUTIONS, CLUBS OR SHOW SOCIETIES***

1. Skriftelike aansoek om 'n skou onder die beskerming van die Genootskap aan te bied, moet jaarliks aan die Raad van die SA Boerperd Telersgenootskap gerig word.
To present a show under the auspices of the Society, written applications must be submitted annually to the Board of the SA Boerperd Breeders' Society.
2. Skriftelike goedkeuring moet verkry word van die Raad vir die datum van so 'n skou.
Written notice and approval for the dates of the show must be submitted to the Board.
3. Instansies / streke / organiseerders is self verantwoordelik vir verkryging van borge, rosette, ens.
Institutions / regions / organisers will be held responsible for obtaining of sponsorships, rosettes, etc.
4. Die bepaalde en vasgestelde minimum klasse moet aangebied word tydens Streek- en Nasionale Kampioenskappe. Verdere byvoegings tot die klaslys berus by die diskresie van die organiseerders.
Minimum classes as prescribed are compulsory for Regional- and National Championships. Additional classes can be included according to the discretion of the organisers.
5. Senior Beoordelaars en baanbeamptes moet gereël word en aan die Raad voorgelê word vir goedkeuring.
Senior Judges and officials must be booked and submitted to the Board for approval.
6. Instansies / streke / organiseerders is verantwoordelik vir enige kostes met betrekking tot die aanbieding.
Institution / regions / organisers are responsible for all costs with regard to the presentation of the show.
7. Genoeg en aanvaarbare fasiliteite moet beskikbaar wees vir die aanbieding.
The facilities of the venue must be adequate and acceptable.
8. Aanbieders sal vir reklame en advertensies verantwoordelik wees.
The presenters of the show will be responsible for their own advertising and marketing.
9. Skou inskrywings word verkieslik elektronies gedoen, maar faks- en e-pos inskrywings word ook aanvaar. 'n Skakel word op die webblad geplaas vir elektroniese inskrywings. Ander inskrywings word gerig aan die persoon deur die Raad aangewys / goedgekeur, wat ook op die inskrywingsvorm aangedui sal word.



Entries can be done electronically (preferably), as well as by means of a fax or e-mail. A link will be placed on the webpage for each show. Other entries will be submitted to the person appointed / approved by the Board, which will be indicated on the electronic entry form.

10. Inskrywingsfooi kan aan die skou organiseerders betaal word.
Entry fees can be accepted by the presenters of the show.
11. Die primêre doel van 'n SA Boerperd skou is om die SA Boerperd as ras te bevorder, sowel as om die Genootskap se beeld uit te bou.
The principal aim of a SA Boerperd show is to improve the SA Boerperd as breed & brand, as well as to promote the SA Boerperd Society's profile.
12. Streekkampioenskapskoue is onderhewig aan die SA Boerperd Telersgenootskap se skoureëls en regulasies.
Regional Championship shows are subject to the show rules & regulations of the SA Boerperd Breeders' Society.
13. Inligting van die skoue/kampioenskappe moet aan alle lede van die SA Boerperd Telersgenootskap deurgegee word d.m.v. elektroniese media, *Communicator* en webblad.
Information of shows/championships must be communicated to all members of the SA Breeders' Society by means of electronic media, "communicator" and web page.
14. Die skouprogram en tydskedule moet minstens 1 week (7 dae) voor aanvang van die skou op die SA Boerperd webblad gepubliseer word en moet op aanvraag beskikbaar wees.
The show program and time schedule must be available on request, as well as published on the SA Boerperd web page at least 1 week (7 days) before its commencement.
15. Uitsonderings sal slegs gemaak word met goedkeuring van die Raad.
Exceptions to the above rules can only be approved by the Board.
