~ Die voorsitter / sameeroper van die plaaslike Skou-komitee of die President van die SA Boerperd Telersgenootskap is vernatwoordelik daarvoor om aan die oortreder die tersaaklike geel kaart waarskuwing uit te reik gedurende die skouperiode. Dit word perd hand gedoen.

~ Indien die aflewing nie gedurende die skou gedoen kan word nadat redelike pogings daartoe aangewend is nie, sal die oortreder skriftelik in kennis daarvan gestekl word binne 14 dae na afloop van die skou.

~ Indien 'n persoon meer as een geel kaart tydens een/meer skoue binne die bestek van 1 jaar ontvang, sal die oortreder outomaties vir 'n tydperk van _____ geskors word.

~ Die skorsing is van krag vanaf die datum waarop die SA Boerperd Telersgenootskap uitgereik is.

APPLICATION**

Excerpt form Code of Conduct

~ This procedures can be applied to cases of offences mentioned in the Annexures to the Constitution, Division C: Shows and Judges under the auspices of the SA Boerperd Breeders' Society.

~ The chairperson /convenor of the Show Committee or the President of the SA Boerperd Breeders' Society must notify the person responsible for the offender during the period of the event that such person shall receive a Yellow Card Warning which will be delivered either by hand.

~ If after reasonable efforts the person responsible cannot be notified during the event, the person shall be notified in writing within 14 days of the event.

~ Should one person receive more than one yellow card warning at the same event / any other event within one year of delivery of the first yellow card, such person shall be automatically suspended for a period of _____ after official notifications from the SA Boerperd Breeders Society have been issued .
