## **1. VERBODE MIDDELS / PROHIBITED SUBSTANCES**

- Die gebruik van gemmer, dwelm- en verbode middels of enige ander vorm van middels wat irritasies mag veroorsaak is ontoelaatbaar.
  - Die Skou-komitee het die reg om te enige tyd, enige perd, in die teenwoordigheid van die eienaar/gevolmagtigde, te laat toets vir verbode middels.
  - Eienaars/gevolmagtigdes moet hulle volle samewerking verleen.
  - Toetsing vir verbode middels moet deur 'n gekwalifiseerde persoon gedoen word.

- *The use of ginger, drugs- or any banned substance or any other form of irritants is prohibited.*
  - *The Show committee has the right to test any horse at any time for prohibited substances in the presence of the owner/assignee.*
  - *The owner/assignee must give their full support.*
  - *Testing for prohibited substances will be executed by a qualified person.*

## **2. TOETS VIR VERBODE MIDDELS TYDENS KAMPIOENSKAPPE / TESTING FOR PROHIBITED SUBSTANCES DURING CHAMPIONSHIPS**

- Die eerste 5 plasings in 'n Kampioenskapsklas klas sal outomatis in aanmerking kom vir die toets van verbodemiddels.
  - Enige perd(e) kan na 'n Kampioenskapsklas genomineer word om getoets te word.
  - Alle ander perde wat ingeskryf het vir die skou mag ook, op 'n nominasie basis, in aanmerking kom vir 'n toets vir verbode middels.
  - Nominasies word deur die Skou-komitee, beoordelaars en 'n Veearts gedoen.
  - Genomineerde perde word aangekondig en die eienaar/verantwoordelike persoon in kennis gestel. Die genomineerde perd gaan onmiddellik na die Veearts se gesteriliseerde stal vir die toets.
  - Versuiming hiervan sal lei tot onmiddellike diskwalifikasie.
- 
- *The first 5 places in a Championship class will automatically be eligible for testing for prohibited substances. Any horse(s) in this Championship group may be tested or nominated at random for testing.*
  - *All other horse at a show may randomly be nominated for the testing of prohibited substances.*
  - *Nominations will be done by the Show Committee, Judges and the Veterinarian.*
  - *As soon as a horse has been nominated and announced, the owner/responsible person will be notified.*
  - *The horse must immediately be taken to the sterilised Veterinarian stable for testing.*
  - *Failure to do so will lead to immediate disqualification.*

## **3. GEVLOGE VAN POSITIEWE TOETSING VIR VERBODE MIDDELS / CONSEQUENCES FOR TESTING POSITIVE FOR PROHIBITED SUBSTANCES**

- Indien enige perd, wat deelgeneem het aan die skou, positief getoets word vir verbode middels sal so 'n perd, vir alle prestasies behaal tydens die skou, gediskwalifiseer word.
  - Alle pryse of toekennings wat ontvang was, moet terug gehandig word.
  - Die eienaar/vertoner sal beboet word in ooreenstemming met die DISSIPLINÊRE KODE.
  - Die eienaar van 'n perd, wat positief toets vir verbode middels, sal verantwoordelik gehou word vir die betaling van die rekening van die toets.

- *If any horse which participated in the show, is tested positive for prohibited substances, such a horse will forfeit any achievement attained at the show and will be disqualified.*
  - *Any prizes or awards obtained must be returned.*
  - *The owner/participant of the horse will be fined in accordance with the DISCIPLINARY CODE.*
  - *The owner of a horse which tested positive for prohibited substances, will be held responsible for payment of the account for the test.*
